Policy Rationale and Purpose

This policy has been created to document BTYC's National Club's Carnival team selection policy. Due to the size and overall cost of this event, the club has chosen to send only its highest performing teams from each Gymsport.

As an alternative, the club will also identify other interstate style competitions, so that every gymnast who doesn't qualify for National Clubs, still has an opportunity to compete at this level.

Please note, this policy may be frequently amended, in lie u of Gymnastics Australia's evolving entry requirements, each year.

Policy Description

Outlined below, is the specific policy of qualification for BTYC's National Clubs Teams. It explains how gymnasts from BTYC can expect to be selected for this competition and the relevance to the level in which they choose to compete. Due to the differences between apparatus and occasionally, team size, MAG and WAG may have subtle differences in requirements. These have been kept to a minimum, where possible.

WAG & MAG

BTYC will utilize at least one and up to two trial events, for qualification. These trial events will be advertised in advance to each program and could be a mixture of both internal events (qualification test) or external events (other club invite).
 Note: Where less than 3 gymnasts meet the qualification at trial 1, no team will be sent for that level/division and trial 2 will not be required.

- Trial 1: Automatic Qualification for the WAG & MAG athletes, that meet the qualification score for their level/division
- o From the list of automatic qualifiers, the top 6 WAG and top 8 MAG gymnasts will be selected as BTYC's team per Division/Level.

Only if places remain available and at least three gymnasts have qualified from Trial 1

o **Trial 2:** Remaining team positions will be filled with top performing athletes with <u>any</u> score. A gymnast that qualifies at Trial 1, is not required to do Trial 2

Team Positions Available

BTYC will only send 1 team per MAG 'Division' and WAG 'Level', where we have 3 or more gymnasts meeting the qualification score in Trial 1.

Team Size:

6 WAG Gymnasts per Level 8 MAG Gymnasts per Division

Team size and qualification scores are subject to change, when the GA event bulletin is published.

Qualification Score Required

WAG Level 5 – 6	36.5 AA
WAG Level 7 – 10	44.5 AA
MAG Level 7 Under 13 & All Level 6	45 AA with apparatus of no less than 6.5
MAG Level 7 Open, 8 Under 14 and 8	
Open	60 AA with apparatus of no less than 9
	63 AA with apparatus of no less than 10,
	unless they are an apparatus specialist,
MAG Level 9 U15, 9 U17, 9 Open and 10	in which case they need no less than 11.5
Open	on the chosen apparatus

Travel Information

Gymnasts will travel as a team with the BTYC Coaches and Volunteer Chaperone.

o In line with Gymnastics Victoria's travel policy, gymnasts aged 12 or under, will travel with the team, but <u>must</u> be accompanied by a parent/guardian.

Please note: Team size and qualification scores are subject to change, when GA event bulletins are published.

Non-Attendance of Trial Events

While the club wishes to send its highest performing team, due to the specific time limits, dates and process for entry to National Clubs (dictated by GA), gymnasts might be ineligible to be selected for a BTYC Team.

If unable to attend either Trial Event: Gymnast will be ineligible for selection

If team positions are still available after Trial 1: Gymnast may still be selected by attending Trial 2

If no team positions are available after Trial 1: There will be no Trial 2 event to attend
